Three Rule Package: On March 1, 2018, DNR hosted the eighth Advisory Committee meeting on the 3 Rule package (including Biocriteria, Designated Uses, Site-specific Criteria for P). The meeting was convened so that DNR could walk the committee through the language changes proposed in the draft phosphorus site-specific criteria rule (new ch. 119).

The Advisory Committee was given time to independently review the language changes proposed in the draft ch. 119 and provide comments to be discussed during the ninth Advisory Committee meeting convened April 19, 2018.

DNR received comments from 4 groups (approximately 47 comments in total, with some overlap). DNR was able to address 32 through revisions, clarifications were made to address another 8 comments, and 7 comments are still under discussion. Rule language on items addressed is still under internal review. The draft language shared at the meeting was not final.

A summary of the rule feedback and adjustments is not provided in this report update, but is available upon request. Additionally, feel free to contact Tyler Linton for electronic copies of DNR's proposed Rule language for NR 119, as well as handouts and a copy of the slide presentation given at the April 18, 2018 Advisory Committee meeting.

Total Nitrogen Standards: the DNR water evaluation section was contacted for news on total nitrogen standards development. The DNR indicated the triennial standards review process is still underway and the DNR has not yet determined what topics will move forward for the next three years. Nitrogen and ammonia are two topics that were suggested to DNR through the topic solicitation process. As the next step, DNR expects to seek information from DNR staff and stakeholders on which topics are most important. This should happen in the next few months.

Ammonia Criteria - Tyler Linton/Great Lakes Environmental Center

Ammonia criteria may be pursued by DNR depending on the outcome of the triennial standards review process; see report under **Nutrient Criteria**.

Water Infrastructure Financing - Vacant

WEF Water Week Fly in Report – Bandon Koltz

WEF Water Week Fly-In activities were held April 17 and 18. In addition to WEF, participating organizations included American Water Works, Association of Metropolitan Water Agencies, National Association of Clean Water Agencies, the US Water Alliance, WaterReuse, the Water Research Foundation, and the Water and Wastewater Equipment Manufacturers Association. This combined organizational effort allowed consolidated visits to Capitol Hill. Keith Haas (Racine), David Botts (Janesville), Nancy Quark and Mandie Smith (Green Bay Water), Martye Griffin and Jennifer Sereno (Madison MSD) and I visited some or all the Wisconsin Representatives and two Senators. Having individuals from Representative districts helped facilitate meetings with staff or the representative. To the degree we can have individuals from each district, it increases interest in the discussion in each office.

Having visited offices for several years, the water infrastructure funding issue was generally well received. The staff and in one case Representative Gallagher appeared informed and recognized the importance of water and wastewater infrastructure funding to Wisconsin.

The “ask” document calls on Congress to:

- Double drinking water and wastewater SRF funding,

-
- Reauthorize and boost funding for Water Infrastructure Finance and Innovation Act (WIFIA)
 - Increase funding for national priorities water research grant program to \$20 million
 - Strengthen protection of the nation's waters =in the 2018 farm bill
 - Increase finding for the USDA rural water/wastewater loan and grant program
 - Increase funding for the Bureau of Reclamation's water recycling program to \$60 million

In addition, the WEF Stormwater Institute included informational material, noting that in 1970, 85% of impairments were from industrial and wastewater effluent discharges; by 2010 85% were from urban and agricultural runoff. EPA estimates that \$150 billion is needed for MS4 and CSO investment over the next 20 years. With this information, a further request was made to include stormwater infrastructure in the next congressional needs assessment for water and wastewater.

EPA provides an update as part of Water Week. The following summarizes comments:

- David Ross/Assistant Administrator Office of Water –
 - Address needed changes in law for treatment and reuse
 - More consultative rather than directing
 - Aging wastewater infrastructure has \$750 billion need
 - Investments must be spent efficiently
 - Waters of the United States - the 2015 rule has been remanded and is being rewritten; a revised rule is expected to be out for comment late summer 2018
 - Nutrient management – one size does not fit all; encourage watershed solutions including trading, encourage ag management practices such as constructed wetlands, keeping nutrients on the farm
 - There will be examination of the impact of perfluorinated compounds, particularly for biosolids.
 - Rulemaking for blending will be examined to bring consistency across EPA regions and clarity to permitting.
 - There has been talk of rescission for the recently passed omnibus budget bill for FY 2018. Concern was expressed from the attendees that recent SRF/WIFIA funding would be reduced.
 - Attendees expressed concern for reduction in Office of Research and Development funding and activities. Ross stated that here was increase in use of research from USGS and USDA.
- Deborah Nagle/ Director Office of Science and Technology
 - Aquatic life criteria – nutrient criteria for lakes/reference criteria are undergoing updates. The stream/response method is being re-examined
 - The 1985 methodology for toxics is being updated
 - Aluminum criteria is being made easier to use; update expected end of 2018
 - Chloride criteria is not undergoing an active re-examination, however information is being gathered – there is no timeline for changes

-
- Recreational criteria – mycotoxin/mycocystis proposal expected end of May
 - Coliphage criteria - information is still being gathered; analytical techniques are being examined, not timeline for actual criteria development
 - Better risk assessment tools for biosolids are needed
 - The national nutrient survey is being conducted to examine nutrient removal with secondary treatment; it is still voluntary. The goal is to identify nutrient removal optimization methods.
 - Analytical methods being examined include real time control instrumentation.
 - Andrew Sawyer/Director Office of Science and Technology
 - Incremental improvement is envisioned
 - Lead, CSOs asset management are continuing focus
 - WIFIA - The \$25 million appropriation will leverage \$3 billion
 - SRF was increased by \$300 million to \$1,7 billion in the recent omnibus bill
 - The Water Finance Center will lead the update of the affordability discussion (the infamous 2% MHI criteria). In particular, MHI may not reflect affordability for a large number of lower income residents/ratepayers. The financial criteria will be updated from the 1997 Guidance – expect draft guidance in 2019.
 - Governance of utilities is a challenge – especially for small utilities. There are 14-17,000 units in the US. Andrew favors consolidation.
 - Chris Kloss will be the point person for the blending rulemaking.
 - Integrated planning is encouraged – wastewater, water, stormwater.
 - Peter Grevatt/Office of Groundwater & Drinking Water
 - Look at practices holistically. Control of lead in drinking water with orthophosphate increases wastewater costs; need to find better solutions
 - Affordability extends beyond CSO – there is one ratepayer
 - A rule is being developed for perchlorate in drinking water per a consent decree.
 - Nutrient in surface water effect drinking water supplies
 - John Goodin/Office of Wetlands, Oceans and Watersheds
 - WOTUS is being jointly re-proposed by EPA & Corps of Engineers – There were 685,000 comments. States, tribes and other stakeholders are weighing in. Expect to finalize applicability 2020
 - 303(d) program – redirect efforts to “post litigation” era (?) states should prioritize impaired waters while protecting healthy waters.
 - Nutrient management in watersheds: partnership needed with USDA, identify key vulnerable watersheds and apply techniques on the land for reductions
 - Panel Questions
 - Nutrient survey will be sent out when approved by OMB
 - With lower detection points for compounds, share the information with and risks with the public - example 70 ppt PFA is the level of concern for drinking water
 - Eliminate blocks to water quality trading

EPA then had several round table discussions:

- Funding
- Technology, Innovation and Resource Recovery
- Water Reuse, Bureau of Reclamation Title XVI Program & CWA/SDWA Intersection Issues
- Integrated Planning, CSO, SSO & Peak Flow Management
 - I attended this session with Chris Kloss– Discussion revolved around integrated planning and the update of affordability guidance. Because the blending guidance was just announced, Chris could not give much additional information.
- Stormwater & Green Infrastructure
- USDA /Conservation Programs/Farm Bill
- Research Issues
- Energy/Water Issues

Congressional Staff also provided updates with respect to committee actions in the Senate and House. Majority and minority views on legislative activities. WRDA and the Farm Bill were the main focus of discussion.

I appreciate the opportunity to represent Central States Wisconsin Section and urge continued support of our Sections participation in Water Week activities. Our congressional Representatives and Senators recognize our organization and our expertise in water issues in Wisconsin. And each year there is greater recognition of the importance of funding for Wisconsin water infrastructure. When new people are elected, there is a new educational process. And with changes at EPA, the eventual effect locally can be anticipated. The WEF Government Affairs Committee provides regular updates through This Week in Washington – You can subscribe if interested. The Committee also has occasional webinars and updates if warranted.

Industrial Waste – Jay Kemp, Chair

Planning is underway for the Pre-treatment Seminar to be held August 15, 2018 at UW Oshkosh. Rich Onderko and Amanda Kaminsky have joined the committee. Nora Erlandson has retired- the Committee appreciates her many years of service to the Section.

1. Management

Matt Clagherty/WDNR joined the committee call for the first time. Matt is the Phosphorus Implementation Coordinator for WDNR. Has been with the WDNR for 2 months. His prior experience included watershed monitoring coordination with the Michigan Tip-of-the-Mitt Watershed Council.

A. Annual Plan

Glenn Tranowski noted consider developing a stormwater/green infrastructure tour destination list for the 2019 Annual Meeting tour. Last year in Minnesota, there was an Annual Meeting tour of a baseball field, a brewery, etc. all highlighting green infrastructure implementation? For Illinois, Strand helped organize the tour planned for this year including a tour stop at a tunnel under a river in Joliet.

Julie McMullin noted that the 2018 Annual Meeting does not have a stormwater track. All of the stormwater presentations were put on the poster track. It has been helpful to have a track devoted to stormwater and watershed issues at prior Annual Meetings.

For the 2019 Annual Meeting, the Organizing Committee includes Dave Arnott as he is the incoming CSWEA President next year. Julie can talk with Dave about the need to have a watershed/stormwater track for 2019.

To encourage watershed/stormwater abstracts, keep in mind that the Annual Meeting abstracts are due approximately the Wednesday prior to Thanksgiving.

B. Annual Meeting Watershed and Stormwater Presentation Topics

Overall there are not a lot of abstracts from the stormwater and watershed committee this year – this is clearly an opportunity to improve upon in coming years. There is a watershed management leadership workshop for 3 hours that includes: DRSCW, and a discussion of the Fox River watershed plan. However, the watershed tour is scheduled at the same time as this watershed leadership workshop. Need to make sure the watershed tour does not conflict with tracks in 2019.

C. State Watershed and Stormwater Activity Updates

1. NE Wisconsin Activities

Bill Hafs provided an update: Since the last call, NEW Water has been analyzing 2017 data. In 2015, there was at 30% cover crops in the Silver Creek watershed, 70% in 2016, and 85% in 2017. NEW Water believes this will eventually translate into some good water quality improvements. ON March 30 NEW Water submitted a phosphorus

preliminary compliance alternatives plan to WDNR. The next steps NEW Water is taking include a final compliance alternatives plan due at the end of 2018 along with an adaptive management plan and WDPES permit re-application. The preliminary plan proposes Adaptive Management combined with some enhancements at the De Pere WWTP facility.

Ashwaubenon Creek and Dutchman Creek are the watersheds that NEW Water would select for Adaptive Management. Advantages includes that they are located right next to Silver Creek. Some land owners in Silver creek also farm in Ashwaubenon and Dutchman creeks. The size of the two watersheds is also roughly equivalent to the pounds of phosphorus needed.

Glenn Tranowski noted that Jason Knutson/WDNR noted at an earlier YP event this year that the Upper Fox TMDL would be coming out this year.

2. Madison/Rock River Activities

Jen Hurlbaas provided an update: 1. Last week Yaharra WINS released 2018 grant program for \$60k in funding opportunities. This is also advertised on the Madsewer.org website. Last week, there was a promotion on sweeping up winter salt.

There is a Pumping Station 15 – open house planned to celebrate earning the ISI Envision Gold award for the project. Bioretention basins capture all of the stormwater, and the site includes a green roof, and solar power, as well as an information on aquatic invasive species control. Madison is requiring ISS Envision evaluations for all of their projects.

There is the Clean Lakes Alliance Breakfast – on Wednesday May 2. This has been a successful fund-raised for over five years.

At a recent YP event – Jason Knutson/WDNR noted that there have been 36 MDV's issues in 2017.

Jim Bachhuber provided an update: Agreements are signed for the USGS leaf management study. 33 municipalities pledged funding. Will be expanding the leaf management credit approach. WNDNR is developing a committee (Standards oversight committee – SOC) for proprietary stormwater practices.

3. SE Wisconsin Activities

Brandon Koltz provided an update: The Milwaukee River Basin TMDL was finalized and approved by EPA. The Southeastern Wisconsin Watersheds Trust (SWWT) is working on an implementation plan for the bacteria TMDL. There is a white paper being reviewed by SWWT for a risk based approach and prioritization of different activities to reduce bacteria loading. A challenge is that 90 percent of the bacteria sources remain unidentified within the watershed.

Julie McMullin provided an update: MMSD is making progress on implementing TMDLs. The MMSD Commission is considering May inter-government agreements to cooperate on addressing TMDL requirements with municipalities.

Oak Creek and the IKEA site was noted as having some high quality wetlands that include habitat for a rare crayfish and salamanders. Salamanders are usually indicators of high quality wetlands and it is noteworthy that even in a very developed metropolitan area that good habitat can still exist.

4. Western Wisconsin Activities

No update.

5. Wisconsin River Activities

Jon Lindert provided an update: There is a February draft TMDL report. WDNR requested comments by April 23. This is not an official public comment period, but instead WDNR will reissue a draft in May/June timeframe. Some of the comments have been around bigger picture implementation issues. The League of Municipalities also submitted comments. This draft information does not have a requirement for sediment reduction, but rather only phosphorus. Hope to have this finalized by end of 2018.

6. Other Activities

Great Lakes Diversion Approved in Racine County for the Foxconn project.
