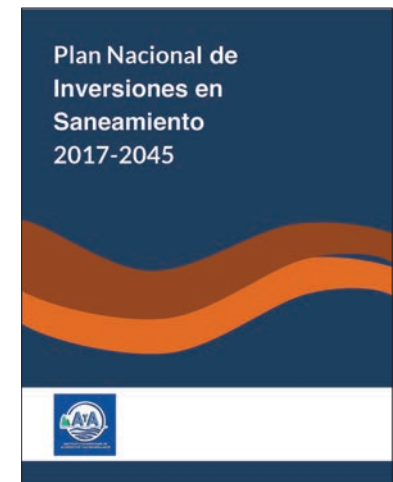
**\$520 Million
in Projects**

In March of 2017, Costa Rica approved their first national policy on wastewater sanitation. This long-term national policy outlines plans and projects from 2016-2035. Its funding plan includes **\$520 million** in infrastructure to provide centralized sanitation to the county.

AyA has already initiated projects around the county. The main sanitation project is the *Environmental Improvement Program* in the Metropolitan Area of San Jose, which is investing over **\$345 million** in sewer systems, pumping stations, and the expansion of the 'Los Tajos' Wastewater Treatment Plant, started in 2015.

Over the next 15 years, AyA will be investing over **\$160 million** in several projects in coastal locations, including: Playas del Cocó - Sardinal, Tamarindo, Puntarenas, Palmares, Quepos, Jacó and Golfito on the Pacific coast, and Puerto Viejo, Moín, and Limón cities on the Caribbean coast.





Only 14% of Costa Rica's wastewater is treated properly. The virtual nonexistence of centralized wastewater treatment in the country means that Costa Rica and the AyA officials are eager to welcome US wastewater experts and products into their sanitation initiatives.

GWS has been volunteering in Costa Rica since 2014, bringing education opportunities, public awareness, and connecting local water districts and national wastewater officials to local and international tools to catalyze their sanitation efforts.
